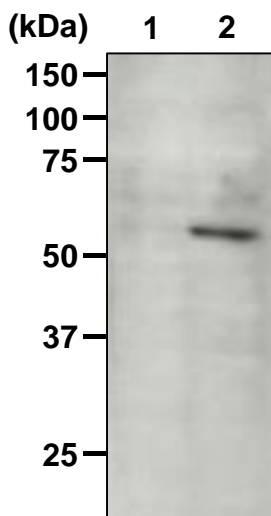

SDS-PAGE & Western blotting

- 1) Culture the cells in the appropriate condition on a 6-well plate until they reach about 90% confluence.
- 2) Wash the cells with PBS and resuspend them with 50 μ L of RIPA buffer [25 mM Tris-HCl (pH 7.6), 150 mM NaCl, 1% NP-40, 1% sodium deoxycholate, 0.1% SDS]. Transfer the lysate to a tube. Incubate on ice for 30 min.
- 3) Centrifuge the tube at 12,000 \times g for 20 min. and transfer the supernatant to another tube.
- 4) Mix the supernatant with equal volume of Laemmli's sample buffer.
- 5) Boil the samples for 5 min. and centrifuge. Load 5 μ L of the sample per lane in a 1-mm-thick SDS-polyacrylamide gel (10% acrylamide) for electrophoresis.
- 6) Blot the protein to a polyvinylidene difluoride (PVDF) membrane at 1 mA/cm² for 1 hr. in a semi-dry transfer system (Transfer Buffer: 25 mM Tris, 190 mM glycine, 20% MeOH). See the manufacturer's manual for precise transfer procedure.
- 7) To reduce nonspecific binding, soak the membrane in 10% skimmed milk (in PBS, pH 7.2) overnight at 4°C.
- 8) Incubate the membrane with primary antibody diluted with 5% skimmed milk (in PBS, pH 7.2) as suggested in the **APPLICATIONS** for 1 hr. at room temperature. (The concentration of antibody will depend on the conditions.)
- 9) Wash the membrane with PBS-T [0.05% Tween-20 in PBS] (5 min. x 3 times).
- 10) Incubate the membrane with the 1:10,000 Anti-IgG (Rabbit) pAb-HRP (MBL; code no. 458) diluted with 5% skimmed milk (in PBS, pH 7.2) for 1 hr. at room temperature.
- 11) Wash the membrane with PBS-T (5 min. x 3 times)
- 12) Wipe excess buffer on the membrane, then incubate it with appropriate chemiluminescence reagent for 1 min. Remove extra reagent from the membrane by dabbing with paper towel, and seal it in plastic wrap.
- 13) Expose to an X-ray film in a dark room for 1 min. Develop the film as usual. The condition for exposure and development may vary.
